The above-named parties appeal from the Memorandum Opinion and Order of the U.S. District Court for the Eastern District of Arkansas that was entered on August 19, 2019 [Doc. 70], and the Final Judgment entered on August 19, 2019 [Doc. 71]. The Memorandum Opinion and Order [Doc. 70] granted Defendants' motion to dismiss in part, granted Defendants' motion for summary judgment, denied Defendants' supplemental motion for summary judgment, and denied Plaintiffs' motion for summary judgment. The Final Judgment dismissed Plaintiffs' claims with prejudice.
