On November 5, 2021, OSHA published the Emergency Temporary Standard, “COVID-19 Vaccination and Testing” in the Federal Register, 86 Fed. Reg. 61402 (Ex. 1). The Court has jurisdiction, and venue is proper in this Court, pursuant to 29 U.S.C. § 655(f).
