PLAINTIFF'S NOTICE OF VOLUNTARY DISMISSAL WITH PREJUDICE

Comes now the Plaintiff, by and through counsel, and, pursuant to Federal Rule of Civil Procedure 41(a)(1)(A)(i), files this voluntary dismissal with prejudice, stating as follows:

- 1. Plaintiff filed this lawsuit on February 14, 2012, seeking a preliminary and permanent injunction enjoining the Defendant from prohibiting Plaintiff from displaying religious, pro-life flyers at Dixon High School.
- 2. On March 1, 2012, Plaintiff filed a Motion for Preliminary Injunction requesting the Court to enjoin District Policy 2170 and Regulation 2170 facially and as applied to prohibit Plaintiff from displaying religious, pro-life flyers at Dixon High School.
- 3. On May 24, 2012, the District's Board of Education adopted revised District Policy 2170 and Regulation 2170 which permit students to display posters and flyers at designated locations in each school in accordance with the permissible restrictions and requirements set forth therein.
- 4. Defendant has agreed to permit Plaintiff to post literature at Dixon High School, including religious and pro-life material, so long as Plaintiff and the material she wishes to post comply with revised District Policy 2170 and Regulation 2170.

5. Defendant's insurer has agreed to pay attorneys' fees in the amount of \$7,000 to Plaintiff. Plaintiff will not seek any additional attorneys' fees or costs in this case.

Based on the above actions of the Defendant, Plaintiff hereby voluntarily dismisses this action with prejudice.
