## AGREED ORDER GRANTING PARTIES' AMENDED JOINT MOTION FOR ENTRY OF STIPULATED PRELIMINARY INJUNCTION

THIS CAUSE is before the Court on the Parties' Amended Joint Motion for Entry of Stipulated Preliminary Injunction (hereinafter "Motion"). The Court has reviewed the Motion, and is otherwise fully advised in the premises. Defendants have shown good cause for the relief sought in the Motion.

Accordingly, it is **ORDERED AND ADJUDGED** that the Parties' Amended Joint Motion for Entry of Stipulated Preliminary Injunction is **GRANTED**.

Pursuant to the agreement of the Parties, it is hereby ordered that:

- The Defendants, their officers, agents, employees, representatives, and all persons acting in concert, or participating with them, agree to be enjoined as follows:
  - a. So long as twenty-four hours advance notice is provided to Dr. Patty Anderson by e-mail as to the date and location, Plaintiff Christina Beattie (hereinafter "Beattie") and Mr. Mario William Martinez (hereinafter "Martinez") shall be permitted to disseminate leaflets and/or converse with the general public ("Leaflet") on the Palm Beach State College's (hereinafter "PBSC") campuses with a table and chair provided by PBSC as follows:

<u>Lake Worth</u> – In front of the bookstore at Martin Luther King Jr. Plaza or 10 to 20 feet to the east of the crosswalk on the NORTH side of the Cafeteria five days during the month of January (except January 18, 19 and 20, 2011 as to Martin Luther King Jr. Plaza) and for up to four days during the month of February.

<u>Palm Beach Gardens</u> – Entrance to the AA Classroom Building and the Rubenstein Pavilion for up to five days during the

month of January (except January 13, 2011) and up to four days during the month of February.

<u>Boca Raton</u> – In front of the Cafeteria or breezeway between classroom buildings "A" and "B" for up to five days during the month of January (except January 19, 2011) and up to four days during the month of February.

Belle Glade – the Parties shall agree to a mutually convenient location for up to five days during the month of January and up to four days during the month of February.

- A "day" shall mean up to six hours of Leafleting per day or less.
- c. All of PBSC's other rules (for instance, relating to littering or appropriate student conduct) shall apply to Plaintiff Beattie and to Martinez, as they would any other student of PBSC.
- 2. All current deadlines in this matter shall be postponed until March 1, 2011, to provide the Parties an opportunity to revise the Polices and otherwise resolve the remaining issues of this matter. To the extent an issue arises resulting in impasse, either Party may inform the Court by filing a Notice and, thereafter, the Court shall reset the deadlines in this matter; and,

This Court will have the power to enforce the terms of this Stipulated
Preliminary Injunction by contempt order and/or sanctions as necessary in the
Court's discretion.

Plaintiff's Motion for Preliminary Injunction (DE8) and Motion for Bond Waiver (DE9) are DENIED AS MOOT.
