STIPULATED DISMISSAL AND SETTLEMENT AGREEMENT

NOW COME the Parties, through their respective counsel, and hereby file this Stipulated Dismissal and Settlement Agreement, stating as follows:

- 1. Plaintiff filed a Complaint (Doc.#1) and Motion for Preliminary
 Injunction (Doc. #9) challenging Defendants' Parade and Demonstration
 Ordinance as unconstitutional both on its face and as applied to
 Plaintiff's religious speech activities;
- 2. Defendants dispute Plaintiff's claims and deny any and all liability related thereto;

- 3. The Court conducted a hearing on Plaintiff's Motion for Preliminary Injunction on October 31, 2007;
- 4. On November 2, 2007, the Court entered an Order (Doc. #24) granting Plaintiff's Motion for Preliminary Injunction and enjoining Defendants from enforcing their Parade and Demonstration Ordinance pending a final resolution of this case;
- Soon thereafter, the Defendant City of Cumming formally rescinded its
 Parade and Demonstration Ordinance;
- 6. WHEREAS, the Parties have now reached a permanent settlement that will dispose of the entire case and which includes the following terms:
 - a. Defendants agree that with the rescission of the City's parade and demonstration ordinance, Plaintiff does not have to obtain a permit to distribute literature on City sidewalks. Plaintiff must, however, abide by all other applicable local, state, and federal laws;
 - b. Defendants agree to pay Plaintiff a monetary amount to settle his alleged violation of his constitutional rights; and
 - c. Defendants agree to pay Plaintiff's attorneys' fees in a predetermined amount.

7. Based on this Agreement and pursuant to Federal Rule of Civil Procedure 41(a)(1)(A)(ii), the Parties hereby agree to dismiss this action with prejudice.
